CERTIFIED DEVELOPMENT COMPANIES PROVIDE LOANS TO EXPANDING BUSINESSES

Small Business Administration Loans in the 504 program, are available through a conduit called a Certified Development Company. Each CDC is governed by a 25 member board of directors representing community, financial and local government officials.

The program offers subordinated mortgage financing to healthy and expanding eligible small commercial and industrial business concern, combining the incentive of long-term(10-20 years), low down payment and reasonable financing(near long-term U.S. Treasury bond rates).

The 504 program can inject up to \$500,000 of the eligible project cost. The minimum project is \$50,000 and loans are denominated in \$1,000 increments. This means that projects of one million dollars or more can be funded through the program.

Land, building and equipment with a remaining useful life of 10 years or more can be financed through the program.(continued on next page)
